PRIVACY POLICY

Effective as from: 12 August 2025

1. Scope

This **Privacy Policy** explains how WWSF/FSMF collects, uses, and protects personal data in accordance with the Swiss Federal Data Protection Act (FADP) and the EU General Data Protection Regulation (GDPR).

2. Data We Collect

We may collect the following personal data when you interact with us:

- Automatically collected data: IP address, browser type, device information, pages visited, and time spent on the site (used for statistical and traffic analysis).
- Data you provide directly: Name, email address, mailing address, organization, and any other details you voluntarily submit (e.g., when subscribing to newsletters, registering for events, or contacting us).

3. Purpose of Data Processing

Your data will be used solely for:

- Internal analysis to improve our website and programs.
- Sending newsletters, invitations, and updates about our activities and programs.
- Responding to inquiries and requests.

We do not sell, trade, or rent your personal data to third parties.

4. Legal Basis for Processing (GDPR Article 6)

We process your personal data based on:

- Consent (e.g., when you subscribe to our newsletter or member registration form and program choice).
- Legitimate interests (e.g., analyzing site traffic to improve services).

5. Data Storage & Security

- Your data is stored securely on servers located in Switzerland or the EU.
- We take appropriate technical and organizational measures to protect your data from unauthorized access, alteration, disclosure, or destruction.

6. Data Retention

We will keep your personal data only as long as necessary for the purposes stated above or as required by law. You may request deletion of your data at any time.

7. Your Rights under GDPR

You have the right to:

- Access the personal data we hold about you.
- Request correction or deletion of your data.
- Withdraw consent for future communications.
- Request a copy of your data in a portable format.
