Message from WWSF President/CEO

2020 Campaign - 19 Days of Activism for prevention of Violence Against Children and Youth 1-19 November



Dear Partners and Friends,

We are happy to share with you our annual campaign **Impact Report “19 Days of Activism for the prevention of violence and abuse against children and youth” 1-19 November 2020.**

Given the circumstances of COVID-19, we received in 2020 less registrations from our coalition network and grassroots groups. We wish to thank all registered member organizations and their program shared with WWSF, and for activity reports and results during the campaign.

Our special acknowledgment goes to:

1) FICE Romania (International Federation of Educational Communities-Section Romania), **that mobilized in 2020, 260’000** students in **1’188** schools, involving **20’00** teachers, psychologists, policemen, social workers, journalists, physicians and parents and organized over **187** workshops, round tables, debates, participation in local, regional and national TV programs. Over **2’000** direct activities carried out with and by children in kindergarten and participating schools. Over **200** activities were organized with parents, grandparents and relatives of children; **700** meetings with specialists, policemen, doctors, psychologists, priests etc. as well as **83** circles of compassion and forum theater and puppet shows. See pages 24-26.

2) PO Drugie Foundation, Poland, that mobilized an estimated 16’000 participants (**6’341** children, **5,215** youth and **4’591** adults) and **565** workshop activities, **375** lectures with the use of films, **143** debates, **272** art competitions and **826** talks about violence. There were **7** conferences, **75** webinars and **752** information boards with tips on how to deal with violence in their 2020 programs. See pages 22-23.

3) The Haven Initiative, Nigeria, for their daily creative social media alerts, and which was selected for our yearly 19 Days WWSF Innovation Prize (\$US 1’000). The award recognizes civil society action that spreads the mission of the 19 Days campaign, builds local networks, raises awareness and supports coalition members. See page 15.



The SDG Target # 16.2 continues to be our inspiration for 2030 and our online training program “Circles of Compassion” is being used by several coalition members. It reminds all of us of its Call to Action **“End abuse, exploitation, trafficking, & all forms of violence against & torture of children.”**

Summary of the organization:

Haven Initiative is a Non-Governmental, Not-For-Profit, humanitarian and development organization who works for the education for disadvantaged/advantaged children, the protection of women & children against violence and abuse, coaching, mentoring, and psychosocial Support

NIGERIA

HOPE FOR SECOND CHANCE FOUNDATION (HOSEC), Ibadan



Summary of the organization:

Hope for Second Chance is an NGO that offers support for errant young adults through rehabilitation and reintegration in Nigeria.

The 19 days of activism for prevention of violence and abuse against children and youth is an organized strategy in the fight against abuse/violence. HOSEC Foundation joined with other stakeholders to participate with the 19 days activism in the following ways:

MARKET SENSITISATION:

9 markets in the Ibadan metropolis of Oyo State Nigeria were selected for the market sensitization. At these markets, the men and women were sensitized on the factors that engender the different forms of violence against children and youth. They were enlightened on available support structures within the states with a toll free number given to encourage speaking out. IEC materials were distributed to sustain knowledge. In view of the COVID-19 pandemic, nose masks and hand sanitizers were distributed at these markets. **A total of 250'000 men and women were sensitized.**

SCHOOLS SENSITIZATION:

4 schools were selected for the school sensitization. On the 2nd of November, HOSEC Foundation sensitized the students of Queens School, Apata on different forms of child sexual abuse and its prevention, dangers of Female Genital Mutilation, knowing and protecting their rights. Bearing in mind the realities of the COVID-19 pandemic, particularly as the second wave just hit us, PPE (nosemasks and hand sanitizers) were distributed

to the girls in a bid to protect them from contracting and spreading COVID-19.

On the 12th of November, the parents and teachers of Bristol Ville schools were sensitized on how to safeguard their children and effective parenting strategy. IEC materials were distributed to sustain knowledge.

It's important to include the celebration of the Universal Children's Day, 20th November, 2020. HOSEC celebrate with pupils at King's Heritage Nursery/Pry School and Vincy Froebel Model School. Child friendly version of the Oyo State Child's Right Law donated by JDPC were distributed to pupils in the high primary class. PPE (nose masks and sanitizer were also distributed to the pupils and teachers. **In all, a total of 8'605 students with 105 parents and teachers were sensitized.**

MEDIA ADVOCACY:

Leaning on media partnership, HOSEC Foundation was able to enlighten the public on child protection and prevention of violence against children through an interview on BCOS Saturday Special and indigenous interview on Splash 105.5fm. **Total Media Reach: 5'978'400 people**

DIGITAL MEDIA:

Digital contents targeted at children were also produced and propagated online to inform and educate children on how they can participate in prevention efforts. These contents also alerted on FGM and child sexual abuse in a child appropriate language. These contents produced in both English and the indigenous Yoruba language and reached a **total number of 65'700 people.**

Summary of the organization:

Amani Initiative is a Ugandan Non-Governmental organization founded in 2011 to prevent and respond to teenage pregnancy and child marriage through low-cost high impact community led interventions with a focus on education, child protection, sexual and reproductive health, and social & economic empowerment.

Themes tackled:

All 19 campaign themes were presented during the 19 Days via social media alerts, sharing activities and ideas for action from the WWSF 19 Days Prevention Kit.

Summary of the report:

Amani Initiative kicked off the brand the month of November, 2020 by joining Women’s World Summit Foundation for annual 19 Days of Activism from 1st-19th November dedicated to the prevention of violence against children and youth directly contributing to Global Goals for Sustainable Development Goal Target 16.2. Our Board Chairperson shared a video speech that was highlighted on our social media platforms.

Our key activities during the 19 Days included, social media key messages, community dialogues and school outreach as highlighted in the report with activities across Uganda and reaching out to over 12,000 people.

PUERTO RICO

NUESTRA ESCUELA, INC Caguas



Summary of the organization:

Nuestra Escuela is a community-based non-governmental organization, incorporated on August 11 2000 under the laws of the Commonwealth of Puerto Rico, with the purpose of offering educational services to youth and adults.

Themes tackled:

Prevention of Bullying

The School Harassment or Bullying workshop was presented to all the participants. The term was defined, and the purpose of the workshop was explained. It was explained to the students the different ways that bullying occurs and effects its victims. The students were able to review the Bullying Prevention activities and rules that exist in Nuestra Escuela's regulations.

Prevention of Discrimination based on Health Conditions (excerpts from their report)

"Mr. Esteban Figueroa, who has a degree in special education is a science and mathematics specialist in Nuestra Escuela. Mr. Figueroa provided different alternatives to work with students with disabilities or functional diversity, that can help and be used during virtual classes. Mr Figueroa orientated the specialist's and teachers on different alternatives to evaluate their students and how to make the virtual classes more effective for all students including students with special needs..."

Prevention of Abduction (excerpts from their report)

The workshop was facilitated by Agent Yamilé Ortiz, an active police officer in the Municipality of Loíza.

It was directed as an active conference, where the students participated actively. She oriented about the different ways that a kidnapping can occur and how to prevent them, including minimize the probabilities of scam calls. She also emphasized in the importance to protect each other's diversity, confidentiality, and privacy.

Prevention of Malnutrition

Students from the Elementary program in Nuestra Escuelita participated in a Workshop on prevention of malnutrition. The Workshop was provided by Social Workers in training from the Interamerican University in Puerto Rico, Fajardo Campus.

Animated videos about children's healthy nutrition were presented. Children were able to express what a healthy and nutritious diet consists of, as well as the beneficial and positive advantages for their health.

The children were able to reflect on the groceries that they have in their home and to categorize them as healthy or not healthy.

Prevention of Drugs and Alcohol Abuse (excerpts from their report)

The workshop was provided to all high school students about the prevention of abuse and controlled substances. Students were oriented about the different kinds of drugs that exist and are common in Puerto Rico. Discussions about all the effects, mental and physical, that are provoked by the use of controlled substances. Different and positive ways to prevent bad decisions due to peer pressure were also discussed.

Summary of the organization:

Navjyoti India Foundation is a not-for-profit organization that envisions to challenge the socio-economic inequalities and enable the vulnerable sections of the society towards the goal of self-reliance. Their mission is to mobilize and harness the power of children, youth, women and people at large to approach illiteracy, gender discrimination and drug addiction with an ultimate aim of crime prevention and inclusive socio-economic development.

Themes tackled:

Prevention of Child Sexual Abuse, Prevention of Bullying, Prevention of Child Labor, Prevention of Abduction, Prevention of Traditional Harmful Practices, and Prevention of Malnutrition.

UDISHA New Delhi



Summary of the organization

Udisha is a non-political, voluntary organization. It has Special Consultative Status with the Economic and Social Council (ECOSOC) of the United Nations. Udisha is involved in various activities like development, environment, literacy, protection of child rights and prevention of child abuse, crimes against women and youth employment. The organization has been a coalition partner of the Women's World Summit Foundation in Geneva for the last fifteen years and participates in the annual "19 Days of Activism Campaign for the prevention of violence against children and youth" every year.

Excerpts from their report:

"Keeping in view the present circumstances, Udisha decided to hold an International Webinar on the Topic: "Has COVID 19 Pandemic Heightened Potential Impact of Existing Forms of Violence, Abuse and Exploitation in Children?" The Webinar was organized with the support of Delhi State Legal Service Authority and Bhagidari Jan Sahyog Samiti/NGO.

It was a proud moment for Udisha as Ms. Elly Pradervand, Founder President, Women's World Summit Foundation/ Geneva and creator of '19 Days Campaign' consented to deliver the Inaugural Address. She spoke on the topic "Heightened Risks and Prevention of Online Violence and Abuse Against Children and Youth during Pandemic."

Other Speakers included Mr. Karnal Singh, Senior Indian Police Services Officer and Cyber Crime Expert and Dr. B. Ramaswamy, Senior Advocate, Supreme Court of India. While Mr. Karnal Singh addressed the participants on Cyber Crime Laws for Safety of Children in the time of Pandemic, Dr Ramaswamy spoke on Curbing increasing cases of Online Violence and Abuse of Children- Legal Perspective. (...)

(...) Mr Rakesh Gaur, Founder President, Udisha in his concluding remarks briefed the audience about the association with WWSF and impact of the 19 Days Activism Campaign being commemorated by Udisha for the last 16 years.

The audience included thousands of Lawyers, nominated by the Delhi State Legal Services Authority, teachers, and trainee teachers from the District Institute of Education & Training (DIETs), NGO Representatives, college and school students and the general public. About **263 participants registered** for the webinar and more than **1500 participated** through live streaming. The webinar was an effective endeavor of Udisha in times of the pandemic COVID-19 and had a positive impact. We received very good feed back from many participants."

CROATIA



OMBUDSMAN FOR CHILDREN Zagreb



Summary of the organization

"Ombudsman for Children is an independent institution in Croatia that protects, monitors and promotes the rights and interests of children in accordance with the Constitution of the Republic of Croatia, international treaties, legally binding acts of the European Union and laws."

The Ombudsman for Children informs and advises children how to realize and protect their rights and interests. The Ombudsman for Children cooperates with children, encourages children to express their opinion and respects their opinion, initiates and participates in public activities aimed at the improvement of the position of children and proposes measures to enhance the influence of children in society."

Description of activities

The Ombudsman for Children organized a series of activities that focused on many of the 19 Days Campaign themes.

- Made a public announcement of the start of the annual campaign "19 Days of activism for prevention of abuse and violence against children and youth 1-19 November 2020" on their [website](#).
- The Ombudsman has highlighted the topic of prevention of any violence against children, and sent a [recommendation](#) to the competent ministries, calling on the institutions involved in the Protocol on Domestic Violence and activities to effectively prevent and protect children from all forms of violence, given the new circumstances.
- On the occasion of the European Day on the Protection of Children against Sexual Exploitation and Sexual Abuse, the Ombudsman sent a [recommendation](#)

to the Prime Minister and the Ministry of Justice on the adoption of a special regulation regulating the protection of children from sexual abuse and sexual exploitation.

- As in-person meetings with children were not possible due to the COVID-19 pandemic, these meetings were organized online.
- On **November 19 and 20, 2020** the Ombudsman for Children organized [zoom meetings](#) with students of the Primary School "Nikola Tesla" in Rijeka, the Primary School "Trilj" and the Primary School "Sv. Petar Orehovec," as well as by children from the SOS Children's Village Ladimirevci.
- Participated in activities in the [Project week](#) "Love, tolerance and freedom - stronger than a pandemic," held from 19 to 27 November 2020 in cooperation with Primary School "Nikola Tesla" in Rijeka.
- [The new calendar](#) of the Ombudsman for Children for 2021 is dedicated to the topic of participation of children, which was sent to a number of schools, homes for children, associations and numerous institutions and organizations that work with and for children.
- We have actively participated in numerous activities and events that were organized by other stakeholders.

All the events received media coverage. It is estimated that a large number of children and adults were reached by these activities, including participants in all the events and a larger public via media releases and our [website](#).

POLAND

Introducing the Foundation:

The PO Drugie Foundation in Poland is a local organization that aims at helping children and youth at risk of social exclusion, violence, and abuse. The organization has been awarded multiple prizes owing to its support for youth and children through diverse rehabilitation centers and educational institutions. Their services include, and are not limited to, psychological help, legal assistance, and self-empowerment.

Summary of the report:

272 entities took part in the 2020 edition; mainly organizations and institutions working with children, youth and families: kindergartens and schools, educational, care and educational, socialization, rehabilitation centers, probation centers, schools, school complexes, probation teams, youth educational and socio therapeutic centers, social welfare centers, county family support centers, non-governmental organizations, foster care facilities, private persons, day support centers, the police, municipal police, cultural institutions, non-governmental organizations and district offices. The media were involved in the operation - regional TV stations, radios, Internet channels.

It is estimated that the total number of recipients of the campaign's activities reached about **16,000** people - **6,341** children, **5,215** - youth and **4,591** adults. It is assumed that the increase in the number of direct recipients of activities is associated with the change of the form of online activity for most entities. All activities undertaken by the Partners were focused on the prevention of violence and interventions against the already existing violence. There were over **565** workshop activities, **375** lectures

with the use of films, **143** debates, **272** art competitions and **826** talks about violence. There were **7** conferences, **75** webinars and **752** information boards with tips on how to deal with violence.

The formula of the Campaign remained unchanged - individuals could apply for the implementation of the Campaign on their own or join coalitions and act interdisciplinary, together to counteract violence. It is estimated that over 60% of partners have established partnerships, building local initiatives and combining their knowledge and skills to build a world free from violence.

It is worth noting that a large part of the activities undertaken in the social campaign were aimed at working on resources, strengthening already existing skills and redirecting attention to activities building the local community. The message was twofold - on the one hand, there were talks and workshops on the violence itself and counteracting it, on the other - the development of constructive, positive relations and attitudes between members of the community.

WWSF congratulates FICE Romania for its renewed remarkable annual nation-wide mobilization campaign to spread prevention measures of violence against children and youth and empowers, especially schools, to transform their country.

Summary of the organization

FICE Romania (International Federation of Educational Communities - Romania Section), based in Bucharest, is a professional non-profit organization, established in 1990 and its main mission is to protect and promote the rights of the child in Romania. It is a national section member of FICE International, a non-governmental organization affiliated with UNESCO, ECOSOC, European Union.

Summary of their report

The themes of the 19 Days campaign focused on sexual abuse, bullying, child neglect and exploitation, physical abuse (corporal punishment), child prostitution and child pornography, child trafficking, harmful traditional practices (early marriage of girls in roma communities), street children, substance abuse and addiction (juvenile addiction), juvenile justice, with special attention being paid to November 2, November 19 (International Day for the Prevention of Child Abuse) and November 20 (World Children's Day).

"The 2020 edition of the 19 Days campaign to prevent abuse and violence against children and young people **was attended by approximately 260,000 students from the 1188 schools in all regions of the country enrolled in the project, over 20,000 teachers, psychologists, police, social workers, journalists, doctors as well as parents. Of the 1188 schools, 612 were from urban areas and 576 from rural areas.**

Between November 1-8, when most of the schools in the communities that had the degree of infection below 1.5/1000 inhabitants carried out activities in the green scenario, i.e. face to face, in school, respecting the rules of distance and hygiene, the following activities were performed:

- **187 workshops, round tables, debates, participation** in local, regional and national television programs
- **Over 2000 direct activities** performed with and by children from participating kindergartens and schools
- **Over 200 activities** performed with parents or grandparents and relatives of children (in situations

- where parents are working abroad)
- **Over 700 meetings** with specialists (police, doctors, psychologists, priests, etc.)
- **83 circles of compassion**

On **2 November** 2020, “compassion circles” were created, through which children from communities/schools where cases of child abuse and extreme suffering (including deaths in school or family, as a result of acts of violence) were remembered. The children built “altars” dedicated to their colleagues, lit candles, placed photos of the abused children, put bouquets of flowers, letters, messages of compassion for families, etc.

After **9 November**, the prevention activity moved to the online environment, carrying out a series of activities under the guidance of teachers, i.e. making posters, collages on topics related to abuse prevention, designing letters and writing thematic essays to send to local authorities and politicians, making drawings to highlight children's anti-violence messages, designing media projects, films and videos, and information sessions especially in the form of ppt presentations, etc.

Throughout the campaign, the schools and institutions registered in the project sent to e-mail address specially defined for the campaign “activism19zile@outlook.com” and on the FICE Romania website, www.ficeromania.wix.com/ficeromania, photos or clips from activities carried out.

On 19 November, the World Day for the Prevention of Child Abuse, FICE Romania organized online on the cisco / webex platform, under the high patronage of the Romanian Senate, the Commission for European Affairs, an international conference, theme: “Child Abuse and Violence - approach in the context of the COVID-19 pandemic”

The conference was intended to be a key instrument in contributing to the achievement of United Nations Goal 16.2 (Ending abuse, exploitation, trafficking and all forms of violence against children by 2030) and addressed, through the materials presented, the direction to prevent violence and abuse against children and young people, with an impact on various spheres of society.

The event was attended by specialists from the child protection system, education, health, police, public authorities, non-governmental organizations (psychologists, sociologists, teachers, social workers, police, magistrates, doctors, journalists, representatives of local and central public authorities, etc.)

Unlike a conference held by direct participation, face to face, this conference held online offered the possibility for participation of a much larger number of people than any of the halls of the Romanian Senate could have offered. This

is due to new technologies, such as the webex meeting platform and the Facebook social networking platform. Facebook offered the possibility for the entire audio-video content to be available live for at least 460 specialists in the field and continued to be available long after the conference, being viewed by over 2100 interested people.

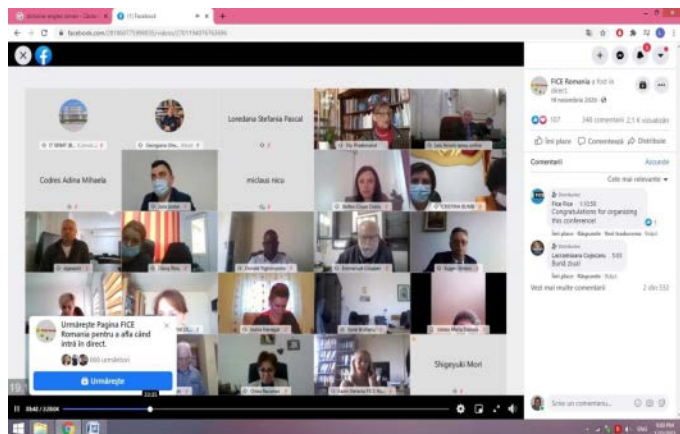

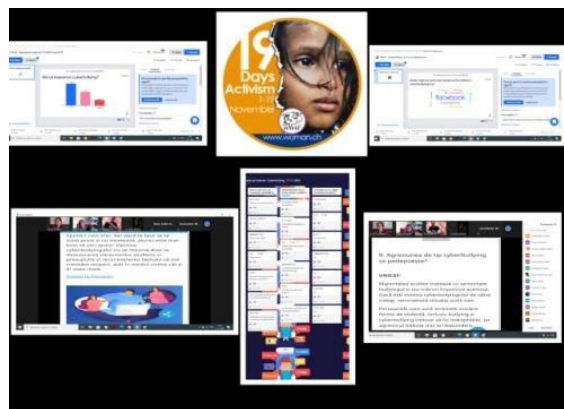

Convention on the Rights of the Child

The UN Convention on the Rights of the Child (CRC) is the most ratified UN Treaty and has plays a central role to improve the lives of children around the world.

Preamble

The preamble recalls the basic principles of the United Nations and specific provisions of certain relevant human rights treaties and proclamations. It reaffirms the fact that children, because of their vulnerability, need special care and protection, and it places special emphasis on the primary caring and protective responsibility of the family. It also reaffirms the need for legal and other protections for the child before and after birth, the importance of respect for the cultural values of the child's community and the vital role of international cooperation in securing children's rights.

Article 1

Definition of a child. A child is recognized as every human being under 18 years old, unless national laws recognize an earlier age of majority.

Article 2

Non-discrimination. All rights apply to all children without exception. It is the State's (national government's) obligation to protect children from any form of discrimination and to take positive action to promote their rights.

Article 3

Best interests of the child. All actions concerning the child shall take full account of his or her best interests. The State shall provide the child with adequate care when parents, or others charged with parental responsibility, fail to do so.

Article 4

Implementation of rights. The State must do all it can to implement the rights contained in the Convention.

Article 5

Parental guidance and the child's evolving capacities. The State must respect the rights and responsibilities of parents and the extended family to provide guidance for the child that is appropriate to his or her evolving capacities.

Article 6

Life, survival and development. Every child has the inherent right to life, and the State has an obligation to ensure the child's survival and development.

Article 7

Name and nationality. The child has the right to a name at birth. The child also has the right to acquire a nationality and, as far as possible, to know his or her parents and be cared for by them.

Article 8

Preservation of identity. The State has an obligation to protect and, if necessary, re-establish basic aspects of the child's identity. This includes name, nationality and family ties.

Article 9

Separation from parents. The child has a right to live with his or her parents unless this is deemed incompatible with the child's best interests. The child also has the right to maintain contact with both parents if separated from one or both.

Article 10

Family reunification. Children and their parents have the right to leave any country and to enter their own for purposes of reunion or the maintenance of the child-parent relationship.

Article 11

Illicit transfer and non-return. The State has an obligation to prevent and remedy the kidnapping or retention abroad of children by a parent or third party.

Article 12

Respect of the child's views. The child has the right to express his or her opinion freely and to have that opinion taken into account in any matter or procedure affecting the child.

Article 13

Freedom of expression. The child has the right to express his or her views, obtain information and make ideas or information known, regardless of frontiers.

Article 14

Freedom of thought, conscience and religion. The State shall respect the child's right to freedom of thought, conscience and religion, subject to appropriate parental guidance.

Article 15

Freedom of association. Children have a right to meet with others, and to join or form associations.

Article 16

Protection of privacy. Children have the right to protection from interference with their privacy, family, home and correspondence, and to protection from libel or slander.

Article 17

Access to appropriate information. The State shall ensure the accessibility to children of information and material from a diversity of sources, and it shall encourage the mass media to disseminate information that is of social and cultural benefit to the child, and take steps to protect him or her from harmful materials.

Article 18

Parental responsibilities. Parents have joint primary responsibility for raising the child, and the State shall support them in this. The State shall provide parents with appropriate child-raising assistance.

Article 19

Protection from abuse and neglect. The State shall protect the child from all forms of maltreatment by parents or others responsible for the child's care and shall establish appropriate social programs for the prevention of abuse and the treatment of victims.

Article 20

Protection of a child without family. The State is obliged to provide special protection for a child deprived of the family environment and to ensure that appropriate alternative family care or institutional placement is available in such cases. Efforts to meet this obligation shall pay due regard to the child's cultural background.

Article 21

Adoption. In countries where adoption is recognized and/or allowed, it shall be carried out only in the best interests of the child, and then only with the authorization of competent authorities and safeguards for the child.

Article 22

Refugee children. Special protection shall be granted to a refugee child or to a child seeking refugee status. It is the State's obligation to cooperate with competent organizations that provide such protection and assistance.

Article 23

Disabled children. A disabled child has the right to special care, education and training to help him or her enjoy a full and decent life in dignity and achieve the greatest degree of self-reliance and social integration possible.

Article 24

Health and health services. The child has a right to the highest standard of health and medical care attainable. States shall place special emphasis on the reduction of infant and child mortality and on the provision of primary and preventive health care and of public health education. They shall encourage international cooperation in this regard and strive to see that no child is deprived of access to effective health services.

Article 25

Periodic review of placement. A child who is placed by the State for reasons of care, protection or treatment is entitled to have that placement evaluated regularly.

Article 26

Social security. The child has the right to benefit from social security, including social insurance.

Article 27

Standard of living. Every child has the right to a standard of living adequate for his or her physical, mental, spiritual, moral and social development. Parents have the primary responsibility to ensure that the child has an adequate standard of living. The State's duty is to ensure that this responsibility can be, and is, fulfilled. State responsibility can include material assistance to parents and their children.

Article 28

Education. The child has a right to education, and the State's duty is to ensure that primary education is free and compulsory, to encourage different forms of secondary education accessible to every child, to make higher education available to all on the basis of capacity and to ensure that school discipline is consistent with children's rights and dignity. The State shall engage in international cooperation to implement the right to education.

Article 29

Aims of education. Education shall aim to develop the child's personality, talents and mental and physical abilities to the fullest extent. Education shall prepare the child for an active adult life in a free society and shall foster in the child respect for his or her parents, for his or her own cultural identity, language and values, and for the cultural background and values of others.

Article 30

Children of minorities or indigenous populations. Children of minority communities and indigenous populations have the right to enjoy their own culture and to practice their own religion and language.

Article 31

Leisure, recreation and cultural activities. The child has the right to leisure, play and participation in cultural and artistic activities.

Article 32

Child labor. The child has the right to be protected from work that threatens his or her health, education or development. The State shall set minimum ages for employment and shall regulate working conditions.

Article 33

Drug abuse. Children have the right to protection from the use of narcotic and psychotropic drugs, and from being involved in their production or distribution.

Article 33

Article 34

Sexual exploitation. The State shall protect children from sexual exploitation and abuse, including prostitution and involvement in pornography.

Article 35

Sale, trafficking and abduction. It is the State's obligation to make every effort to prevent the sale, trafficking and abduction of children.

Article 36

Other forms of exploitation. The child has the right to protection from all forms of exploitation prejudicial to any aspects of the child's welfare not covered in articles 32–35.

Article 37

Torture and deprivation of liberty. No child shall be subjected to torture, cruel treatment or punishment, unlawful arrest or deprivation of liberty. Both capital punishment and life imprisonment without the possibility for release are prohibited for offences committed by persons below age 18. Any child deprived of liberty shall be separated from adults unless it is considered in the child's best interests not to do so. A child who is detained shall have legal and other assistance as well as contact with the family.

Article 38

Armed conflicts. States shall take all feasible measures to ensure that children under 15 years old have no direct part in hostilities. No child below 15 shall be recruited into the armed forces. States shall also ensure the protection and care of children who are affected by armed conflict as described in relevant international law.

Article 39

Rehabilitative care. The State has an obligation to ensure that child victims of armed conflict, torture, maltreatment or exploitation receive appropriate treatment for their recovery and social reintegration.

Article 40

Administration of juvenile justice. A child in conflict with the law has the right to treatment that promotes the child's sense of dignity and worth, takes the child's age into account and aims at his or her defense. Judicial proceedings and institutional placements shall be avoided wherever possible.

Article 41

Respect for higher standards. Wherever standards set in applicable national and international law relevant to the rights of the child are higher than those in this Convention, the higher standards shall always apply.

Articles 42–54

Implementation and entry into force. These articles notably foresee:

- the entry into force of the Convention 30 days after its ratification or accession by 20 States;
- States parties' obligation to make the rights of the Convention widely known to both adults and children;
- the establishment of a Committee on the Rights of the Child to consider the reports that States parties are required to submit two years after they have ratified the Convention and every five years thereafter;
- States parties' obligation to submit said reports to the Committee on measures they have taken to fulfill the Convention and the progress being made in their implementation;
- States parties' obligation to make their reports widely known in their own countries;
- International cooperation in the field covered by the Convention achieved by inviting UNICEF and the specialized agencies of the United Nations – such as the International Labor organization, the World Health organization and United Nations Educational, Scientific, and Cultural organization – along with 'competent' bodies such as non-governmental organizations in consultative status with the United Nations to attend Committee meetings and provide expert advice on areas within the scope of their activities, and by the Committee's referring to them States parties' requests for technical advice and assistance;
- the Committee's right to recommend to the General Assembly that special studies be undertaken on specific issues relating to the rights of the child. The rights of the child articulated by the Convention are further reinforced by its Optional Protocols on the sale of children, child prostitution and child pornography, and on the involvement of children in armed conflict.
